Chairman McClain stated for the record that the agenda has been posted and notice has been provided to the local news media as required by the Freedom of Information Act.

APPROVAL OF MINUTES:

Councilman Norris made a motion to approve the minutes of the January 9, 2012, regular county council meeting. Councilman Calhoun seconded the motion. The motion carried 6-0-0.

PRESENTATION:

Abbeville County Fire Marshall Dan Evatt informed all that in 2011 there were 9 recordable accidents; which is less than 2010 which had 11 recordable accidents. The decrease is due to a team effort of all Abbeville County employees.
