# ABBEVILLE COUNTY COUNCIL REGULAR MEETING JUNE 10, 2013 MINUTES

### CALL TO ORDER:

Chairman McClain called the meeting to order at 7:38 p.m.

#### **INVOCATION:**

County Director Bruce Cooley gave the invocation.

#### PLEDGE OF ALLEGIANCE:

Chairman McClain led the Pledge of Allegiance.

### FREEDOM OF INFORMATION ACT:

Chairman McClain stated for the record that the agenda has been posted and notice has been provided to the local news media as required by the Freedom of Information Act.

### APPROVAL OF MINUTES:

- 1) Councilman Campbell made a motion to approve the minutes of the May 13, 2013, regular county council meeting. Councilman Calhoun seconded the motion. The motion carried 6-0-0.
- 2) Councilman Thomas made a motion to approve the minutes of the June 3, 2013, budget workshop. Councilman McCord seconded the motion. The motion carried 5-0-1 with Vice Chairman Stone abstaining.

### PRESENTATION:

Major Melody McClure with the Salvation Army informed Council that the Salvation Army has been helping residents in this area pay their rent and utilities, plus supply food and clothing when needed for 75 years. The contact for Abbeville County is Ms. Mary Smith (366-4647).

### **UNFINISHED BUSINESS:**

- 1) Third reading of Ordinance (2013-04) to establish operating and capital budgets for the operation of the County Government of Abbeville County for the fiscal year commencing July 1, 2013. Councilman Thomas made a motion to amend the Budget by making changes reflected in attachment "A" and to provide that pay increases reflected in the budget only apply to those employees that have been with the County for six (6) months; once employed for six (6) months the employee would then receive a 2% cost of living increase. Councilman Calhoun seconded the motion. The motion carried 6-0-0.
- 2) Third reading of Ordinance (2013-05) making provision for Tax Anticipation borrowing by Abbeville County, South Carolina, in the principal amount of not exceeding \$1,000,000, in anticipation of the collection of Ad Valorem Taxes for the fiscal year beginning the first day of July, 2013 and ending the 30<sup>th</sup> day of June, 2014; to prescribe the terms and conditions of such borrowing and the form of note to be executed evidencing the same; and to make provision for the payment thereof. Chairman McClain made a motion to table third reading until the July meeting. Councilman Campbell seconded the motion. The motion carried 6-0-0.
- 3) Third reading of Ordinance (2013-06) to provide for the issuance and sale of a not exceeding one hundred ninety five thousand dollars (\$195,000) General Obligation Bond of Abbeville County, South Carolina, to prescribe the purposes for which the proceeds of said bond shall be expended, to provide for the payment of said bond, and other matters relating thereto. Councilman McCord made a motion to approve third reading. Councilman Campbell seconded the motion. The motion carried 6-0-0.
- 4) Third reading of Ordinance (2013-07) to adopt new, updated guidelines for Abbeville County Boards and Commissions and to rescind all prior ordinances or resolutions that may be in conflict. Vice Chairman Stone made a motion to approve third reading. Councilman Campbell seconded the motion. Councilman Thomas requested third reading be tabled. Vice Chairman Stone and Councilman Campbell rescinded their motions. Councilman Thomas made a motion to table third reading until July meeting. Councilman Campbell seconded the motion. The motion carried 6-0-0.

Inc., South Carolina for construction of the Industrial Incubator Building at the Lakelands Commerce Center. Councilman Thomas made a motion to approve this resolution. Councilman McCord seconded the motion. The motion carried 6-0-0.
- 5) Resolution (2013-24) recognizing the Josephine Spearman Wright High School and Abbeville County Training School Alumni Association, Inc. (JSW/ACTS), for twenty (20) years of preserving the legacy of the fore mentioned schools. Councilman Calhoun made a motion to approve this resolution. Councilman Campbell seconded the motion. The motion carried 6-0-0. Councilman Thomas presented the resolution to the representatives present.

### **DIRECTOR'S REPORT:**

County Director Bruce Cooley informed Council that the closing of the VA building is scheduled for Friday. The Calhoun Falls EMS station is awaiting trusses and should be complete within two (2) months. Reassessment is now in the City of Abbeville with about 800 left and should be finished by mid July.
